It's that time of the year again...the planning phase for Grenada's Downtown Jubilee which will be on **September 28th, from 9:00 am – 4:00 pm**. You are invited to participate in this fun filled family event of shopping, entertainment, arts and crafts, classic car show, children's activities, museums, train rides, concessions, bungee jump and much more. Also just visiting around and eating with your friends on the square at the Big Tent next to the Courthouse. Last year was our best festival ever with our largest attendance.

Each year we recognize and honor a Hometown Hero who has achieved and brought recognition to his/her home town. This will be in the Gazebo. However, this will not stop the visitors from shopping. Enclosed you will find an application for reservation in the festival. **The deadline will be September 20, 2019...** Please remember to get your reservation in early to insure a good booth spot.

Please read the following Rules, Information and Regulations we ask you to follow:

- ✓ No person is allowed to ride a bicycle within the Jubilee unless given permission to do so by the Jubilee Directors. This is for safety purposes.
- ✓ ABSOLUTELY NO CHILDREN OR YOUTH RUNNING OR PLAYING TAG OR ANY KIND OF BALL AT THE FESTIVAL. SECURITY WILL BE ON WATCH.
- ✓ Set up begins on Saturday, September 28, 2019, at 6:00 a.m. Packets containing your tax envelope will be available at the temporary Chamber office on the square in the Court House. You must have your **vehicle off the square by 8:30 am on September 28th**.
- ✓ Fake blood, guns, knives, cigarettes, and firearms will not be allowed. If such items are sold or displayed, you will be asked to break down your booth and leave the Jubilee.
- ✓ **Vendors** – You must bring your own table, tent, and chairs and extension cords for setup.
- ✓ The Chamber of Commerce reserves the right to remove any items that it feels not suitable for the Jubilee from any vendor.
- ✓ No vendor can exchange spaces with other vendors.
- ✓ Jubilee staff will be on hand to help with any questions that you may have. Periodic spot checks will be performed throughout the festival.
- ✓ Since the Jubilee has a permit to use the city square for Saturday, September 22, no individual is allowed to sell unless you have registered with the Downtown Jubilee Registration Office. Businesses on the square will be open for business. Please respect the arts/craft and food vendors who have paid and registered for this event.
- **NO LOUD GENERATORS WILL BE ALLOWED AT JUBILEE.**

Agreement of Indemnification

For value received _____ (Undersigned), hereinafter "The Vendor," jointly and several agree to indemnify and save harmless The Grenada Area Chamber of Commerce and to successors and assigns from any claim, action, liability, loss, damage or suit arising from the following:

Any action that may arise as a result of the The Vendor operating a vending booth, truck, or other space during the 2019 Downtown Jubilee Festival. This agreement shall cover the entire length of the 2019 Downtown Jubilee Festival beginning Saturday, September 28, 2019, at 9:00 a.m. and ending Saturday, September 28, 2019 at 9:00 pm.

Where any claim is asserted, The Grenada Area Chamber of Commerce shall provide The Vendor with reasonably timely notice of same in writing.

Therefore, The Vendor shall at its own expense defend, protect and save harmless The Grenada Area Chamber of Commerce against said claim or any loss or liability resulting therefrom.

Should The Vendor fail to so defend and / or indemnify and save harmless, then, in such case, The Grenada Area Chamber of Commerce shall have full rights to defend, pay or settle said claim on their own behalf without notice to The Vendor for all fees, costs, and payments made or agreed to be paid to discharge said claim.

The Vendor agrees to pay all reasonable attorney's fees necessary to enforce said Indemnification. This agreement shall be unlimited as to amount or duration, and it shall be binding upon and inure to the benefit of the parties, their successors, assigns and personal agents and representatives.
